Adani Renewable Energy Park (Gujarat) Limited ("AREPGL"), a Wholly-owned Subsidiary of Adani Green Energy Limited ("AGEL") had won a bid for setting up 130 MWac ISTS-connected Wind Power Project in a Tender issued by Solar Energy Corporation of India ("SECI"). The Company has received Letter of Award ("LOA") from SECI for the same. The fixed PPA tariff is Rs. 2.83/ kWh for a period of 25 years. The Project is expected to be commissioned by Q4 FY 2021.

With this, AGEL's portfolio of renewable generation capacity in India stands at 5.29 GWac with 2.02 GWac operational projects and balance 3.27 GWac in development stage.

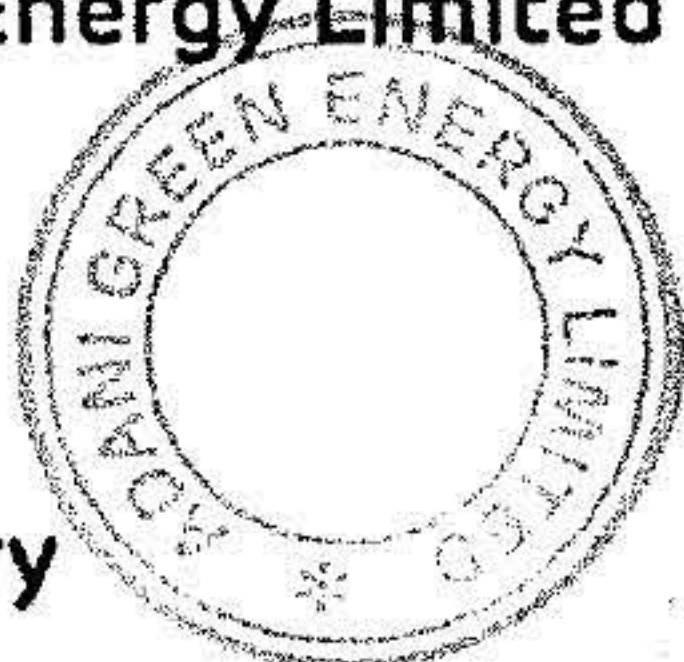
