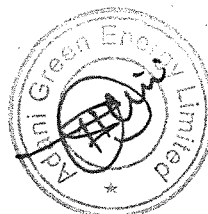

In terms of Regulation 30(9) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, (the "**Listing Regulations**") as amended, we wish to inform you that Adani Renewable Energy (RJ) Limited ("ARERJL"), Wardha Solar (Maharashtra) Private Limited ("WSMPL") and Kodangal Solar Parks Private Limited ("KSPPL" and collectively with ARERJL and WSMPL the "**Issuers**") are wholly owned subsidiaries of Adani Green Energy Limited, directly or indirectly. The Issuers have appointed Barclays, Citigroup, Credit Suisse, Deutsche Bank, J.P. Morgan, MUFG and Standard Chartered Bank as Joint Global Coordinators and Joint Bookrunners to arrange a series of fixed income investor meetings in Asia, Europe and the United States commencing on 25th September, 2019. An offering of USD-denominated Rule 144A / Reg S 20-years senior secured green bonds (the "Notes") (weighted average maturity of 13.35 years) for benchmark size may follow, subject to market conditions. The Notes are expected to be rated BBB- (underlying credit "BBB") by Fitch and Baa3 by Moody's. 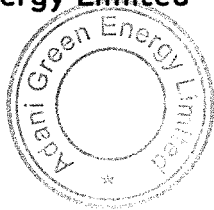
