This is in furtherance of the intimation given by the Company on January 25, 2024, wherein we informed you that the Company had allotted 6,31,43,677 convertible warrants to Ardour, a member of the promoter group of the Company on January 25, 2024, by way of a preferential allotment on a private placement basis. The issue price of Rs.1,480.75 per warrant, out of which Rs. 370.19 (25% of the issue price) per warrant, was received as the initial subscription amount at the time of allotment of the warrants.

In accordance with Regulation 30 read with Schedule III of the Listing Regulations, we wish to inform you that out of the balance 4,29,19,910 convertible warrants allotted to Ardour, Ardour has now opted to exercise and convert 54,55,584 warrants which are convertible into 54,55,584 equity shares of the Company of face value Rs. 10/- each, in compliance with the provisions of Chapter V of the SEBI (Issue of Capital and Disclosure Requirements) Regulations 2018 ("**ICDR Regulations**"), and the terms of allotment of the warrants.
