Centre urges SC for perjury charges against petitioner over claim of 'extra-judicial killings'

The Centre has approached the Supreme Court, seeking perjury charges against a PIL petitioner who had moved the top court accusing security forces of committing extra-judicial killings during operations against Maoists in Chhattisgarh's Dantewada in 2009.

The Centre contended that the nature of the reliefs sought for in the plea filed by Himanshu Kumar and the kin of some of the alleged victims, were aimed at "halting the operations of the security forces and secure legal protection to the Left-wing extremists by creating a narrative of victimisation".

Hearing the 2009 petition, the SC had on February 15, 2010, asked a Delhi district judge to record the statements of the petitioners. The Centre said it had got the copies of the statements of the petitioners after a court order in March 2022 and "found shocking aberrations and fabrications in them".

"...all the averments made by the petitioner in the petition

were ex-facie false and fabricated with a malicious and audacious attempt to mislead the court and to obtain orders from this Hon'ble Court by playing fraud on conscience and magnanimity," said the plea.

The Centre's application also said "it has become clear that this false narrative of a massacre of innocent tribals by security forces was created to somehow achieve immediate cessation of advancement of the security forces against the cornered armed Leftwing extremists. The said object was sought to be achieved, and was in fact achieved by the petitioner, by misleading the Hon'ble Court and by seeking adverse orders against security forces by portraying false facts/picture before the court".

The plea also urged the SC to order a probe by the CBI or the NIA or any other central agency "to identify the individuals/organisations who have been conspiring, abetting and facilitating filing of petitions premised on false and fabricated evidence to screen off the Left-wing militia from being brought to justice by creating a false narrative of victimisation.'

Aakar Patel can't leave country without our permission: CBI court

A CBI court on Friday directed former Amnesty International

India chief Aakar Patel to not leave the country without its permission while staying a Delhi court's order asking the CBI director to issue a written apology to Patel for the Look Out Circular (LOC) issued by the agency that prevented him from leaving for the US two days ago. The stay was issued by Special

Judge Santosh Snehi Mann, a day after the Additional Chief Metropolitan Magistrate (ACMM) asked the CBI to withdraw the LOC issued in connection with a case registered against Amnesty International India in 2019 under Foreign Contribution (Regulation) Act. At the time, Patel headed the organisation.

Taking to Twitter on Friday, Patel said that he "will continue to stand for my rights" and that "there is absolutely no doubt" that he "will win this". Patel was supposed to attend an event titled 'Using sarcasm to mobilise dissent in a nation where facts don't mat-

tor to issue a written apology to Patel for issuing the LOC in order to "uphold public trust in the agency" and "heal his wounds". The judge had ruled that there was an inherent contradiction in the CBI's position -- while the agency claimed the LOC was

issued as Patel was a "flight risk",

it did not arrest him while investigating the case or when the chargesheet was filed. On Friday, the CBI moved a revision petition before the special court, submitting that their right to issue a LOC was erroneously quashed and that the ACMM passed remarks against

the agency's functioning, which

must be quashed as the observations were not made on merits.

Staying the part of the order that asked the CBI director to issue a written apology, Special Iudge Mann told Patel's lawyer Tanveer Ahmed Mir: "Ensure that your client does not do any misadventure. He is not going to leave." The court made the observations after the CBI submit ted that Patel tried to leave the country on Thursday night, which was not disputed by Mir who submitted that the LOC had been quashed by the ACMM.

Appearing for the CBI, Special Public Prosecutor Nikhil Goel told the court that the ACMM "seems to suggest that if you are not arrested in an investigation, an LOC as a matter of rule cannot be issued". He told the court that it would be violative of a person's fundamental rights if the agency has to arrest somebody first to issue a LOC. The court will hear further arguments on this revision petition on April 12.

Earlier on Friday, Mir moved a contempt petition against the CBI seeking action against the investigating officer for contempt of the order quashing the LOC.

Kolkata: The Calcutta High Court Friday handed over the probe into the murder of TMC's deputy gram pradhan Bhadu Sheikh, which allegedly led to retaliatory violence and the killings of at least nine people in Birbhum last month, to
