3 crocodiles spotted in Navlakhi pond, 1 rescued

THE FOREST department on Thursday rescued one three-foot long crocodile from Navlakhi pond, an artificial water body created last year. Effort is on to rescue two more crocodiles spotted in the pond, forest officials said.

The forest department has two days to capture all the crocodiles from the pond before the last day of Dasama Puja when people will immerse idols in the water body. The pond was created in August last year ahead of Ganesh Chaturthi as an alternative to the Sursagar lake, which is undergoing renovation, for idol immersion.

At least 22 crocodiles were rescued from residential areas in Vadodara city and district in the last one week. These reptiles had ventured into residential areas after water levels in the Vishwamitri river rose due to heavy rain and floodwaters entered the city and parts of the district last week.

"We were informed that three crocodiles were spotted in the pond. We sent our team from the forest department and vol-

unteers to rescue the reptiles. We have managed to rescue one, and effort is on to find the others," said Assistant Conservator of Forests, Vinod Damor.

After the first capture in the morning, the rescuers made several failed attempts to rescue other crocodiles. "The water is

15-feet deep and so the rescuers cannot enter the water and capture them. We have been trying to capture the crocodiles using a grip through a long rope held from corner of the pond to the other. The major challenge here is to patiently wait for the reptiles to surface when they can be

captured. They generally surface when the sun is out to maintain their body temperature, but since today it started raining after noon, our attempts failed," Damor added. The forest department will now be placing cages for the crocodiles inside the pond to catch them.

EXPLAINED Flood hassles

THE 15-FEET deep temporary pond, Navlakhi, was built in 2018 ahead of Ganesh Chaturthi and does not have a natural habitat for aquatic animals.

The pond also does not have enough resources to feed the crocodiles who would go without food if they are not rescued from the pond immediately.

In natural ponds, the forest department creates a C-shaped fencing inside the pond to demarcate the boundaries and avoid any animal-human conflicts.

So, crocodiles can co-inhabit in natural ponds and lakes along with humans who use the banks for various chores like bathing, washing clothes etc.

Prime accused in Haren Pandya case sent to jail

A SPECIAL POTA court here on Thursday sent one of the prime accused convicted in the 2003 murder of Gujarat's then home minister Haren Pandya to judicial custody at Sabarmati Central Jail. The trial court's conviction of Asghar Ali had been restored last month by the Supreme Court.

Pandya, who held the Home and Revenue portfolios during the chief ministership of Narendra Modi, was shot dead when he entered his car after a morning walk on March 26, 2003, near Law Garden area in the city.

Asghar Ali was the prime accused and the sharp shooter who was found guilty of pulling the trigger on Pandya.

Advocate Iliyas Khan, representing Ali said, "The court of Judge MK Dave remanded him in judicial custody, implying that his sentence of life imprison-

ment in the Haren Pandya murder case will be executed hereon. He was at a Telangana jail earlier in relation to a murder case."

The apex court on July 5 restored the conviction of 12 persons who were convicted by the special POTA court for murdering Pandya in 2003. The POTA court conviction had been challenged in the Gujarat High Court, which acquitted them.

Of the 12 convicts, three have already undergone their sen-

tences, as stated by the Gujarat High Court in its order. The apex court did not interfere with it.

Of the remaining nine, the Central Bureau of Investigation had moved the special POTA court for issuance of arrest warrant on July 20 for eight of the convicted persons as they were neither in judicial nor police custody. As advocate Khan explained at the time, "Whenever a judgment is pronounced, there is a timeframe mentioned within which the convicts have to turn up. The timeframe was not mentioned by the SC in its order. As the Gujarat HC had acquitted all, they were not in custody."

The POTA court granted CBI the warrant, following which the eight convicts surrendered before the court on July 22.

As Asghar Ali was lodged in a Telangana jail in a separate matter, the CBI sought his transfer. Ali was transferred Thursday, presented in court and sent to judicial custody right away.
