# Police to sensitise people about illegal overseas travel

DAYS AFTER a four-member Patel family from Dingucha village in Gandhinagar was found dead in Canada while allegedly trying to illegally enter the US, the Gujarat Police will be starting an awareness initiative in the village and surrounding areas warning peo-

ple of the perils of undertaking il-

legal travel to other countries. The Anti-Human Trafficking Unit (AHTU) unit of the Gujarat Police will be taking the help of women volunteers of Mahila Suraksha Samiti (Women Protection Committees) at the district level to sensitise the overseas aspirants against the touts allegedly involved in illegal trafficking of undocumented citizens to US, UK,

Canada and other countries. On January 19, the Royal Canadian Mounted Police (RCMP) discovered four bodies frozen, near Emerson town of Manitoba province in Canada

As per the RCMP, the four bodies were part of a larger 11-member group of undocumented citizens from India who were allegedly trying to illegally cross over to the US from Canada.

On January 28, the Canadian authorities identified the bodies as Jagdish Patel (39), his wife Vaishali Patel (37) their daughter

Vihangi Patel (11), and their son Dharmik Patel (3), all residents of Dingucha village under Kalol tehsil of Gandhinagar, who had traveled to Canada on visitor VISA.

Anil Pratham, IPS officer and Director General of Police (DGP) Women's Cell, Gujarat Police told The Indian Express, "We have written to superintendents of police and police commissioners in all cities and districts of Gujarat asking them to sensitize people regarding the perils of undertaking illegal means of travel to other countries through such travel agents."

"The travel agents might boast of getting people inside any country however many times, the victims are not aware of the hardships and risks involved in such plans. Volunteers from Mahila Suraksha Samiti can assist the police in reaching out to the people," he said.

While the law enforcement agencies in US and Canada are currently investigating the alleged human trafficking racket involved in the deaths, the Gujarat Police's Crime Investigation Department (CID) is probing the involvement of travel agents at the local level.

However, as per sources, there have been no detentions or arrests in the case from India vet as the police are awaiting a reply from their counterpart in US and

# 5 held, juvenile apprehended for 'raping' minor

**EXPRESS NEWS SERVICE** VADODARA, FEBRUARY 3

THE NARMADA district police Thursday arrested five persons and apprehended a juvenile over the alleged gangrape of a 16year-old girl.

The FIR, registered at the police station concerned late on Wednesday, states that the incident occurred on January 31 night when one of the six accused allegedly mislead the girl to accom-

pany him to a deserted structure of the public works department and raped her.

The accused then took her to another deserted location nearby, where two other accused were waiting. The three accused took turns to rape her. After the two other accused left, the first accused continued to keep the girl in his custody," the FIR stated.

"He dragged her to a field, where three other accused arrived one after the other and raped her in turns. The accused threatened to kill her and hurled casteist abuse at the girl," it said.

The girl is the complainant in the case. Police said that one of the six accused is a 17-year-old juvenile but the investigating officers are preparing to seek trial for the juvenile.

Superintendent of Police, Narmada, Himkar Singh, told The Indian Express, "The girl is in stable condition as her injuries were not life-threatening... Although one of the six accused is a juvenile, we have taken him into custody and we will seek trial for him as per the amendment to the law after the 2012 Delhi gang-rape case."

Meanwhile, the district police have initiated counselling of the traumatised girl.

The accused were booked under the relevant sections of the POCSO Act, 2012 as well as IPC.

One of the six accused has also been booked under the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities)

Act, 1989.
