Govt signs accord with NDFB, ABSU to resolve Bodo issue

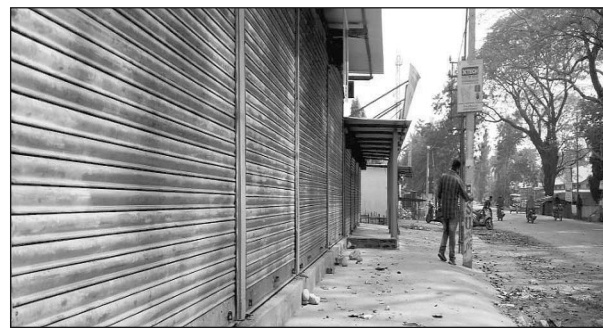
THE GOVERNMENT on Monday signed an accord with the National Democratic Front of Boroland (NDFB), one of the dreaded insurgent groups of Assam, providing a political and economic bonanza without a separate state or Union Territory.

The All Bodo Students' Union (ABSU), which has been spearheading a movement for a

Bodoland state since 1972, and another group called United Bodo People's Organisation were also signatories to the accord.

The tripartite agreement was signed by Assam Chief Minister Sarbananda Sonowal, top leadership of the four factions of the NDFB, ABSU, joint Secretary in the Home Ministry Satyendra Garg and Assam Chief Secretary Kumar Sanjay Krishna in the presence of Union Home Minister Amit Shah.

Shah described the agreement as "historic" and said it will

bring permanent solution to the decades old problems of the Bodo people.

Hailing the accord, Prime Minister Narendra Modi said it would usher in a new dawn of

peace, harmony and togetherness and that those associated with armed resistance groups would now enter the mainstream and contribute to the nation's progress. He said the ac-

cord will lead to transformative results for Bodos as it successfully brings together leading stakeholders under one framework and would help Bodo people get access to development-oriented initiatives.

"Ushering in a new dawn of peace, harmony and togetherness! Today is a very special day for India. The Accord with Bodo groups, which has been inked today will lead to transformative results for the Bodo people," the Prime Minister said on Twitter.

"This agreement will facilitate all round development of the Bodo areas, their language and culture will be protected without compromising the territorial integrity of Assam," Shah said.

The home minister said due to the violence perpetrated by the Bodo militants, over 4,000

people lost their lives in the past few decades. Shah said no stone would be left unturned for the development of Assam and the Northeastern region.

The Assam chief minister Sonowal said after the pact, different communities in the state will be able to live with harmony. Union Home Secretary Ajay Bhalla said the pact will bring comprehensive solution to the Bodo issue. "It is a historical accord," he said.

Assam minister Himanta Biswa Sarma said as per the accord, 1,550 militants belonging to the NDFB will lay down their arms on January 30, an economic programme of Rs 1,500 crore will be implemented in the next three years with equal contribution of Rs 750 crore each from the central and state governments.
